History: A 5-year-old female intact German Shepherd was submitted for necropsy examination on 12/28/11. The dog was suspected to have inflammatory bowel disease (IBD). The owner would like to confirm but they were not sure if possible due to frozen carcass. The dog was euthanized on 12/24/11. The dog had frequent liquid diarrhea from 5 months old and up. Raw turkey diet was best for the dog. Daily prednisone pills helped. Occasional metronidazole treatments were also given. Because the carcass was frozen, the carcass was allowed to thaw and necropsy was performed on 12/31/11.

Enteritis, lymphoplasmacytic, fibrosing, chronic, diffuse

COMMENTS

The lymphoplasmacytic infiltrates and fibrosis indicates chronicity of the inflammation. The microscopic lesions and history of chronic diarrhea is compatible with the clinical syndrome of inflammatory bowel disease (IBD) which is commonly seen in German Shepherd dogs. The causative agent for IDB is unknown but an immunologic reaction to dietary components is suspected.

NECROPSY FINDINGS The dog was in poor body condition with a body condition score of 1.5/5. The lumen of the entire small intestine was filled with greenish to lightly brown liquid material that is mixed with partially digested chunks and strands of fowl smelling food material. The lumen of the large intestine contained greenish soft to liquid feces mixed with large strands of partially digested food material.

There were no gross lesions in the lungs, heart, thyroid glands, stomach, spleen, pancreas, kidneys, ureters, urinary bladder, urethra, musculoskeletal system, reproductive tract, adrenal glands or brain. The

spinal cord was not examined.

HISTOPATHOLOGIC DESCRIPTION

Small intestine: All examined sections of small intestine are similar. The lamina propria of the villi is multifocally expanded by moderate numbers of lymphocytes and plasma cells. Diffusely, the lamina propria is expanded and replaced by increased collagen fibers that separate the crypts. Multifocally crypts are dilated with mucin and eosinophilic secretory material.

There are no significant microscopic lesions in the heart, lungs, stomach, skeletal muscles, pancreas, uterus, or brain.
